RE: Central Issuance of Boat Registrations

[This is the latest in a series of procedural updates. These updates deal with specific MVD procedures and practices. Managers and Supervisors should consistently distribute the updates to all personnel and integrate them into regular information and training sessions.]

Effective tomorrow, December 16, 2010, we will be using a central issuance process for all new and renewal boat registrations. A temporary boat registration, printed at the field office, will be valid for 45 days from the date of issue. The permanent registration and sticker will be sent to the customer by U.S. mail.

Field offices no longer have to worry about how many stickers they have been assigned and no longer need to call Santa Fe for new batch numbers.

A temporary registration is printed at the field office on the same paper stock that is currently used for temporary drivers' licenses and IDs. The temporary registration is valid for 45 days from the date of issue. The permanent registration and sticker will be sent to the customer within 40 days, usually within two to three weeks.

The new boat registration process requires use of the new MVD point-of-sale (POS) system. As a result, only state and county-municipal MVD offices will be able to handle boat registrations. Until they complete their transition to the MVD POS system, private retail agents (PRAs) will not be able to process boat registrations.

The registration renewal notice that is mailed to registered boat owners now contains the information that, to increase the efficiency of the boat registration process:

- MVD has centralized the issuance of all boat registrations in Santa Fe;
- the boat owner will receive a temporary registration at the field office; and
- the permanent registration and sticker will arrive in the mail within 40 days.

The field office workflow steps will be: POS boats; boat registration renewal; data entry; and eventually placing the registration transaction in the shopping cart for payment. You can also print reprints if needed. Boat stickers this year will be blue instead of red.

For your information, samples of the registration renewal notice and the temporary boat registration are included below.

You will receive a temporary registration document at the field office and MVD will mail the permanent registration renewal in the mail within 40 days.
